### **Circular Economy Academy Regional Clinic**

The <u>Rediscovery Centre</u> will be hosting a Circular Economy Academy Regional Clinics in Naas on the 28th of April at11:00am -3:00pm in the Merits Building in Naas, Co. Kildare.

This event will explore new business opportunities for communities, individuals and social enterprises in the circular economy including for example repair, reuse, lending, environmental innovation. This will include:

 an exploratory workshop (11:00am - 12.30pm) discussing opportunities for community projects and social enterprises in the circular economy. This will cover an introduction to design thinking, successful funding models and other support services available and the Rediscovery Centre's own social enterprise journey. The workshop will close with a Q&A and an opportunity to network with like-minded organisations.  30 minute one-to-one mentoring sessions for anyone with a specific circular economy project in mind (e.g. waste prevention, reuse, repair, lending, environmental innovation). These sessions will take place from 12.30pm -3:00pm
