Kildare Public Participation Network. It was a year with lots of changes, filling new Secretariat seats and changing staff. The new Coordinator Grainne Fleming commenced her role on April 6th and worked with the Secretariat, our Funders, and the support worker, Grace Clarke, to get up to speed quickly.

The Department of Rural and Community Development issued a working handbook in November of 2020 highlighting key directives.

### **Climate Action Linkage Group**

The Climate Action Linkage Group held their meetings before and after each Climate Action SPC in 2021. A key focus of the Linkage Group was to work on the pre-draft County Development Plan submission. This was acknowledged as an exceptional and expert piece of work by the members of the Climate Action Strategic Policy Committee.



#### <u>Transportation Linkage Group</u>

The Transportation Linkage Group met 5 times throughout 2021 to discuss issues relating to the Transportation, Safety and Emergency Services Strategic Policy Committee.

The Housing Linkage Group met 3 times throughout 2021. During Q3 the Housing Linkage group consulted with PPN member groups to get their views on Housing issues in Kildare. ### Kildare County Council Community Grants Information Session

Two online Community Grant Information Sessions were held in collaboration with the Community Section in Kildare County Council.

The sessions highlighted the grant scheme guidelines covering what groups were eligible to apply and what projects would be permitted under the scheme. A Questions and Answers session followed, where participants had the opportunity to ask specific questions in relation to their applications.

75 Member organisations participated.

#### Kildare PPN Plenary

On June 15th Kildare PPN held our Plenary meeting via Zoom.

Thirty-five member organisations were in attendance on the night. The workplan and proposed Budget for 2021 along with all documentation, including new and reviewed policies were ratified.

### Kildare County Council Climate and Energy Week

During the Kildare Climate and Energy Week, Kildare PPN Coordinator Grainne Fleming was invited to Chair a panel discussion on 'Community Activation' live from the Chamber on Friday 29th October. The expert panel looked at how communities in Kildare are inspiring and creating change around energy saving and the establishment of Sustainable Energy Communities across the County. It was a pleasure to collaborate on such an inspiring event.



Kildare Public Participation Network Climate Action Weekend took place from the 26th to the 28th of November 2021. This event is organised by members of our Secretariat with a passion for Climate action and

### **Consultations**



### National Dialogue on Climate Action: Climate Conversations

The Climate Conversations are part of a series of conversations that took place across the country connected to the government's National Dialogue on Climate Action. The aim of the Conversations was to inform the development of the National Climate Action Plan.

On the 12th of March, Kildare PPN held our own Climate Conversation via Zoom, facilitated by Cliona Kelliher, Environmental Representative on the Secretariat. We discussed and captured a snapshot of our hopes and concerns for local climate action and our recommendations for the Climate Action Fund, along with recommendations for the Climate Action Plan.

The group had some fantastic insights and ideas and their passion for Climate Action was evident.

The feedback from the Climate Conversation were then collated and submitted to the Department of Environment, Climate and Communication to feed into the National Dialogue on Climate Action.



### <u>Kildare County Development Plan 2023-2029</u> Pre-draft Consultation

Kildare PPN hosted an independently facilitated workshop on the 18th of February to give PPN members the opportunity to discuss and share what they would like to see in the County Development Plan during the pre-draft consultation.

Acting Senior Executive Planner, Jane O'Reilly attended the Zoom meeting, and presented a brief overview of the County Development Plan to participants. This was then followed by an open discussion where all attendees had the opportunity to speak, sharing their ideas and suggestions. These suggestions were then collated and formed Kildare PPN's submission to the County Development Plan which was submitted to Kildare County Council on the 8th of March 2021.

#### **LCDC Community Activities Fund**

Kildare PPN facilitated a member's survey to identify how the LCDC Community Activities Fund could be targeted. This was to aid the LCDC in identifying challenges groups experienced who were impacted by Covid-19. This feedback was then submitted to the LCDC to help advise the remit of the grant scheme.

### The Kildare Strategic Plan for Housing people with Disabilities

Kildare PPN Consulted with 71 member organisations in the Social Inclusion Pillar to inform the Kildare PPN Submission to the Kildare Strategic Plan on Housing people with Disabilities.

### Mazar - PPN Structural Review

Kildare PPN Secretariat, Representatives, Plenary and Staff provided feedback and input to the Structural review of the PPN via written submission and focus groups.







### Internal Consultations with our Plenary (Member Organisations)

As part of our commitment to achieve full inclusion and ensure that the Plenary as the key decision makers are acknowledged and respected, Kildare PPN consulted on a regular basis to ensure we are meeting the needs of all member groups.

### Kildare PPN Constitution

Kildare PPN consulted with our member organisations to make amendments to its constitution on May 4th 2021.

### Training Needs Analysis

Kildare PPN consulted with our member groups on June 16th to establish the training needs to meet gaps to build capacity and skills. The training calendar for 2021 was launched in September 2021 based on the findings

#### Kildare PPN Workplan

Kildare PPN consulted with our member groups on November 23rd to feed into the workplan for 2022 to identify key areas which we need to support them in 2022.



### **ADMINISTRATION**



#### 2021 Work Plan

The Kildare PPN Work Plan for 2021 was approved by the Secretariat on the 25th of January 2021, ratified by the Plenary on the 15th of June, outlining Kildare PPN's main aims and objectives for the year ahead.



### **Income and Expenditure**

Kildare PPN's Income and Expenditure Report for 2020 was finalised and ratified by the Plenary on 15th of June 2021. This can be accessed on the PPN website under the 'Our Governance' section.



### Recruitment of Coordinator

The recruitment process to appoint a new Coordinator was undertaken during Quarter 1 in collaboration with our host organisation CKLP. The position was advertised on ActiveLink, Jobs.ie and Kildare PPN's communication platforms. Suitable applicants were shortlisted and invited for an interview with the Manager of CKLP along with two Secretariat members from Kildare PPN.



### Strategic Plan 2022 - 2026

JVA consulting was engaged in November following a tender process, to develop a Strategic Plan for Kildare PPN and initial consultations commenced.

Staff, Secretariat and Representative consultations took place, followed by member organisations and key stakeholders

It is anticipated that the final draft will be completed in Q1/Q2 2022.
