## Sports Capital & Equipment Programme 2023



The SCEP is the Government's primary vehicle for providing support to sports clubs and communities to develop sports infrastructure around the country. Applicants for local projects can now apply for up to €200,000. The maximum valid grant available for projects deemed to be of regional significance has been increased to €500,000. The first step in obtaining a grant is to register on the Department's online system at <u>www.sportscapitalprogramme.ie</u>

Once registered, all applications must be made on the same website. The system will be open for applications until **8th September.**

HeadsUp will be running their next 12-week programme for men in Kildare Town, September 2023.



## Public Consultation: Public Consultation on Draft Revisions to the Grand & Royal Canal and Barrow Navigation Bye-laws



Waterways Ireland has prepared draft changes to the Byelaws for the Shannon Navigation & Shannon-Erne Waterway, and for the Grand & Royal Canals and Barrow Navigation. The updates are focused on

- Better management of the waterways through annual registration fees and permits;
- Better water quality;
- Limiting biodiversity loss;

## Public Participation Networks - Consultation on Draft PPN Roadmap



An independent Structural Review of the PPNs was carried out in 2021/2022. It recommended a number of actions to make PPN structures work more effectively. The Department of Community and Rural Development (DRCD), in collaboration with the Working Group, has now commissioned Crowe to conduct a consultation on the draft Implementation Roadmap.
