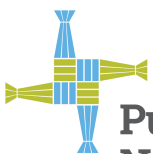



Background

The Vision for Community Wellbeing for this and Future Generations identifies the key issues that member groups in Kildare consider to be important to their communities and to be *“The best that it can be for this and future generations”*

It was developed through an open, participative, transparent process which involves all member groups. It is a key directive from the Department of Rural & Community Development.

CONSULTATION PROCESS

This report provides the high-level findings from a comprehensive consultation process undertaken by Kildare PPN. This process was conducted between July and September 2023. An in-person consultation was held in each of the five Municipal Districts (MD) in Kildare, followed by an online survey which was circulated to ensure maximum participation. In total ninety-four groups participated which generated over eighty pages of detailed data.

The outcome of this is the formation of five Municipal District Wellbeing Visions, along with detailed data which is now available on the Kildare Public Participation Network website.

This vision encapsulates the key themes incorporating all five Visions, however, as stated the granular detail of recommendations can now be found at MD level on the website.

This Vision is a testament to the county's commitment to understanding and addressing the needs and aspirations of its people. Furthermore, it is a real reflection of the strength and commitment of volunteerism in the county and should be commended.



KEY THEMES

The following themes were the themes discussed at the consultations. They formed the structure for discussions and covered a multitude of areas. They were thought provoking and conversations expanded beyond the themes. In each MD we looked at mapping the assets we currently had, which then helped us to identify the gaps we needed addressed (detailed data available on the Kildare PPN website for each MD).



HEALTH PHYSICAL AND MENTAL

Being healthy is more than not being sick, it's about being safe and secure, it's about being able to have good clean food, to be able to get out and about. We know that all of this also helps our mental health, as does having people you can talk to, a place you belong, and space to relax. Unfortunately our health can't always be perfect, and sometimes we need to be able to get professional help. We can't have a hospital at every crossroads, so what makes sense to build a healthy community? What would it look like?



ENVIRONMENT AND SUSTAINABILITY

If you live in a poor environment, everything else suffers. Environment is not just nature and wildlife and waterways, it's also our buildings and streets, towns and our housing. It's about how we manage our natural resources, so that we leave enough for the generations to come. We hear a lot about climate change, and how it is the cause of a lot of the extreme weather. The fact is that we are going to have to change the way we live, moving to renewable energy, making less waste and using less resources. How do we plan for this in a way that sustains the communities?



VALUES, CULTURE AND MEANING

What makes us who we are? What identifies us as a community? Our heritage and our history, our past and our present. What brings us together? What do we do when we gather; sport, music, drama, arts and crafts, spirituality, cards, dance, food, etc. The cup of tea and the chat, the sociable pint, the theatre and drama, the music and song, the neighbourliness that happens when there is a crisis. How will this look in the years to come? How would we want it to look?



ECONOMY AND RESOURCES

Money makes the world go around – and people need enough income to live. We know that work is changing, and lots of the jobs that were there twenty years ago are gone, and lots of the jobs that people do now were not even imagined then. What are the main sources of work in this county, are they secure, what new opportunities are out there? Technology gives us some real opportunities for rural areas. There is a small town in Scotland, where they have set up a working hub and there are about 60 people employed – working for a university in Boston! That's real jobs and quality jobs, bringing income into an area – and where distance is no object.

We also need to look at people who are not in paid work for whatever reason, maybe they are retired, or unemployed, or caring or have a disability. Are there programmes to help them to maintain their skills and learn new ones? To get involved in the community, along with their families?

For the economy to thrive we need good services and infrastructure; Transport, Broadband, Education for all ages, Shops, support for new businesses and old? What local resources and skills do we have and how can they be managed sustainably?



SOCIAL AND COMMUNITY DEVELOPMENT

Everyone talks about the economy, but we don't live in an economy, we live in a community. A good community is probably one where people feel safe and secure, that has facilities to bring people together and they have things to do. What about people with disabilities, or new people or people from different cultures? Men and women? How do we develop a place where people can live without fear, and have places to go, and things to do? A place to be proud of and to belong to. It's also where we look at equality, how do we include everyone, irrespective of gender or sexual orientation, or culture, or ethnic group or age etc.

Communities that work well also have good services and infrastructure – transport, broadband, social services etc. But the most important thing is people!



PARTICIPATION, DEMOCRACY AND GOOD GOVERNANCE

The easy start is participation, volunteering, getting involved, “doing your bit” and encouraging others to do the same. And around you, do you have a voice or a say in the decisions that affect you locally, as well as voting every five years? Are the views of all the different communities of Kildare heard and considered, and not just the ones that shout loudest or are in a so called “golden circle”. You can’t please all of the people all of the time, but can we trust the way decisions are taken? The decisions on how money is spent? and how fair it is? Good Governance would mean that we can – all the way from the Dail to the Council to our own group that runs a lotto, or a Churchgate collection or a table quiz. But does this accountability mean that we are drowning in paperwork and people are put off getting involved in committees? What do we need to restore trust in our charities and voluntary organisations, and keep them vibrant?

COUNTY KILDARE FINDINGS

Health Physical and Mental

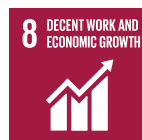

Other priorities that emerged during the consultation process

Safety and Security

Findings

Residents expressed concerns about safety, especially during night time. There's a call for increased Garda presence and better-lit streets.

Recommendations

1

Increased Garda Patrols: Allocate resources for more regular Garda patrols, especially in areas identified as high-risk.

Community Policing: Encourage community Garda initiatives, fostering trust between residents and An Garda Síochána.

3

Infrastructure: Invest in better street lighting and install CCTV cameras at strategic locations.

Infrastructure and Urban Planning

Findings

The rapid growth of the district has led to challenges in infrastructure and urban planning. Traffic congestion limited public transport options, and the need for more recreational spaces and improved accessibility were highlighted during the consultation.

Recommendations

1

Accessibility: A full accessibility audit should be carried out across public buildings and spaces within the Municipal District.

Transportation: Develop a comprehensive transportation plan that includes expanding public transport routes, creating dedicated bike lanes, and improving road infrastructure.

Recreational Spaces: Allocate spaces for parks, playgrounds, and community centres. Consider developing a central recreational facility that can host various sports and cultural events.

Urban Planning: Adopt a sustainable urban planning approach, ensuring green spaces are integrated into new developments and preserving the district's historical sites.

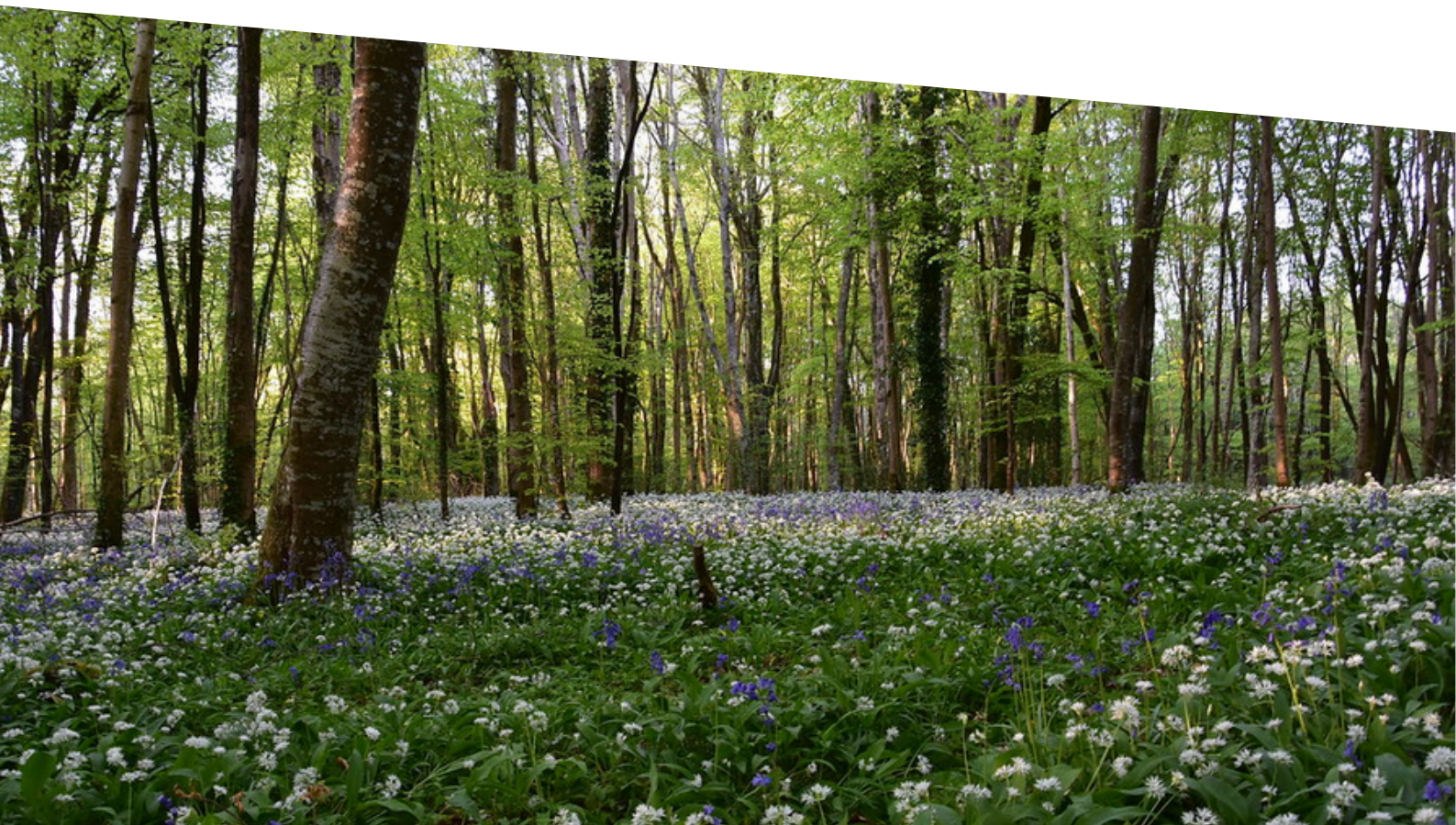

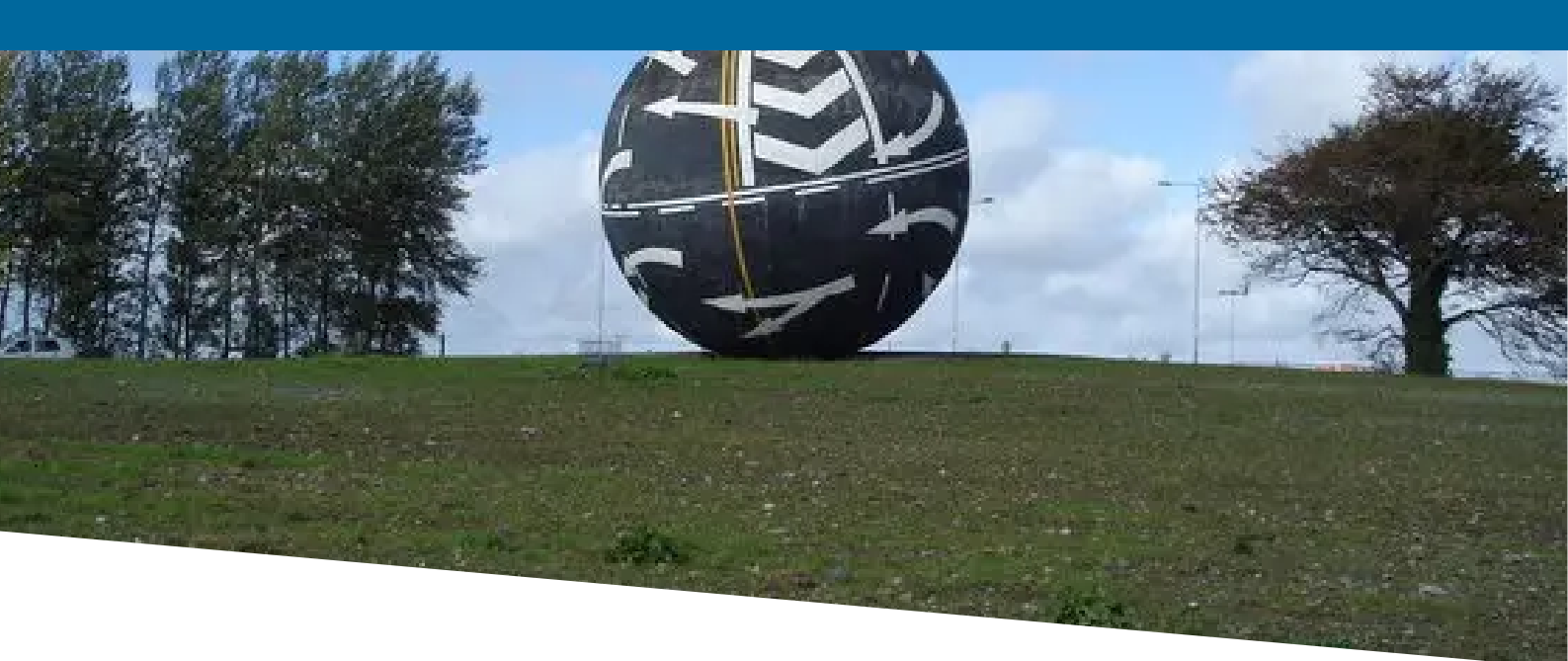
