PPN Stakeholders Breakfast

The Stakeholder breakfast event took place on May 15th in the Osprey hotel. Twentyfive people were in attendance including PPN Representatives, Secretariat members and Kildare County Council elected members and staff.

The event focused on building capacity and relationship building between all stakeholders. The beginning of the event focused on recapping our 'working together for public participation' which took place the previous November, highlighting the role, remit and statutory basis of the PPN along with the committee processes and structure within Kildare County Council.

Marian Higgins, Director of Service for Climate, Community, Environment & Water delivered a presentation on the policy journey from the pre-development stage right through to the implementation.





This event was very well received. It worked on closing gaps between all stakeholders, sharing information and strengthening the role of the PPN representatives on all SPCs and committees.



Plenary Meeting 28th February 2023

Kildare Public Participation Network gathered at the Curragh Racecourse on February 28th to hold our first Plenary meeting of 2023. We welcomed over seventy members to address annual administration, ratification of the 2023 workplan and the budget, along with the launch of the 2022 annual report.

The Plenary, which is held twice a year followed a call out for new members as a new national brand identity and awareness campaign for Public Participation Networks was launched by Minister for Community Development and Charities, Joe O'Brien in Dublin. On the evening Lorraine Benson, the Kildare PPN representative on the Local Community and Cultural SPC with Kildare County Council talked about the positive experience of being a PPN representative and the impact that representatives can have on local decision making. The Annual Report for 2022 was launched by Jill Mulhern, a member of the Secretariat and this highlighted the work completed by both Secretariat and staff throughout the year.





After the meeting, attendees were invited to a behind the scenes tour of the Curragh grandstand, where our members had the opportunity to visit locations that are off limits to members of the public including the weighing room and jockeys dressing room. In addition, all members received tickets to the opening race meeting of the season. The Plenary was held in collaboration with the Curragh racecourse, and we must extend a huge thank you to the team there.













Plenary Meeting

1st November 2023

November 1st saw the final Plenary meeting of the year been held in the Osprey hotel, where member groups were presented with the work plan progress report and financial report for 2023. One of the most important items on the agenda included the change for the future hosting arrangement of Kildare PPN moving forward. The Secretariat presented their chosen option to set up as an independent company to which the Plenary agreed.



We were also delighted to welcome Meabh Boylan, Biodiversity Officer with Kildare County Council as our guest speaker on the evening.

The consultation for our member groups in the Naas Municipal District was held in McAuley Place on the 14th of September. 14 member groups were in attendance.



Following the consultation process, an online survey was sent out to our membership within each of the MD's to ensure maximum participation. 51 individual submissions were received.

The draft statements were then produced and circulated to participants for feedback.

Following the final consultation process, we were delighted to ratify the 6 wellbeing Visions at our Plenary in November. We look forward to using the visions as a roadmap to ensure that the needs of their individual communities are reflected in the work we do. 

Change in Hosting Arrangement

At the end of 2022, Kildare PPN were notified that County Kildare LEADER Partnership (CKLP) would no longer be in a position to host the PPN from 2024 onward and that we would need to source a new hosting arrangement.

In preparation for this, the Secretariat reviewed three

potential hosting options:

- To set up an independent entity (or CLG) to host Kildare PPN
- To find a new host in the community, voluntary or environment sector to replace the role played by CKLP to date or
- To ask Kildare County Council, to host Kildare PPN.

Once their preferred option was chosen, the Secretariat held an online information session for Kildare PPN member groups to answer any questions or concerns they had.

The Secretariat presented options to the Plenary on November 1st and made a recommendation for Kildare PPN to set up as a CLG. This option was then approved by the Plenary and a business case will now be submitted to the Dept of Rural and Community Development by the Secretariat as soon as possible.



Kildare PPN Strategic Plan 2022-2026

As 2023 was the first full year in which our Strategic Plan was in place, we are delighted to report that we have completed or commenced 72% of ongoing objectives. These objectives will continue year on year as we continue to achieve all aims and objectives by 2026.




